

AN EVOLVED CONSULTATION FRAMEWORK FOR A NEW

Strategy for EU Space R&I

Introduction

The European Commission is setting up a new **consultation framework** to develop for the first time a **comprehensive Strategy for EU Space R&I** addressing the **activities of space R&I** funded by the European Union.

The **objectives** of the consultation framework are to:

- Deliver a comprehensive **Strategy for EU Space R&I** as successor of the Strategic Research and Innovation Agenda (SRIA) for EU-funded space research supporting competitiveness.
- Facilitate an open and transparent consultation to gather needs and perspectives from European stakeholders.
- Provide a **focal point for interaction between the different space R&I activities** to foster cross-fertilisation and to identify synergies, gaps and opportunities.

The framework will take into account current and planned space R&I activities related to competitiveness and access to space (at the moment covered by the SRIA), the EU Space Programme R&I and also insights from European space R&I stakeholders.

The core activities in the framework are:

Community events

Regularly, workshops and surveys organised by the European Commission will leverage the different perspectives of the European space R&I community:

- Promoting EU-funded space R&I activities.
- Gathering inputs and perspectives from all interested stakeholders on the way forward.
- Collecting viewpoints and ideas for the Strategy for EU Space R&I




Coordination & cross-fertilisation

Coordination & cross-fertilisation meetings will ensure that the work of the different R&I activities takes place in a consistent framework:

- Informing about the outcomes of the broader consultation process through community events.
- Sharing the status and plans of the R&I activities to identify relevant gaps, synergies or opportunities.
- Discussing perspectives on emerging/disruptive technologies and future business opportunities that could be supported by EU funding.
- Giving way to recommendations for better coordination between R&I activities as well as to recommendations for the preparation of the Strategy for EU Space R&I.

Participants will be the European Commission and R&I representatives¹ from EU Member States as well as other invited guests from European and Member States organisations², depending on the agenda.





- Involving the wider European Space R&I community via workshops and surveys to gather inputs and insights
- Leveraging the H2020 & HE space technology R&I based on the SRIA 2020
- Considering research for the EU Space Programme components Copernicus, EGNSS, SSA, GovSatCom & innovative capabilities
- Coordinating with national space activities on areas of common interest to ensure synergies
 - Improve coordination to fundemental science (ERC, MSCA) and the EU support system for entrepreneurship (CASSINI, EIC)
